

THE PROGRAM

Through this program you will:

- Identify why you started smoking
- Understand addiction
- Assess your tobacco use
- Identify triggers to smoke
- Learn how tobacco companies market their products
- Learn about laws regulating tobacco
- Identify a healthy lifestyle
- Learn about resources that can help you quit using tobacco

The program consists of one, 3-hour class. Participants are only eligible to complete the TOBACCO EDUCATION PROGRAM one time.

Pre-registration for the program is also required. See "Registration" for details.

The TOBACCO EDUCATION PROGRAM (TEP) is **not** a cessation program, however, cessation resources are available for anyone interested in quitting tobacco.

You MUST PRE-REGISTER for the

program prior to your court date and

attend the closest available class to

your court date. Failure to register will

result in full payment of your fine.

Cost of the program is \$25 and must be
paid at the start of class. Make checks

You will receive a letter as confirmation of

registration prior to your class date.

Attendance is required for the entire class

in order to complete the TEP and have

your record kept clear.

Upon completion, you will receive a

certificate of completion that should be

delivered to the law enforcement agency

that issued the citation/summons.

YOUR VIOLATION

If you are reading this, you may have

been issued a citation and/or summons

or been referred to juvenile court for one

or more of the following:

▶ Possession of a tobacco product

▶ Use of a tobacco product

▶ Falsely representing your age to

purchase a tobacco product

If you choose not to enroll in the program,
you must pay the forfeiture and may be
found guilty in court. There will be a
record of your conviction.

By successfully completing the
TOBACCO EDUCATION PROGRAM your
citation/summons will be dismissed.
